A water-borne one-component, polyacrylate exterior topcoat with highest quality on the market.

# Recommended spreading amounts and theoretical coverage

Recommended spreading amounts (unthinned)		Theoretical coverage
wet	dry	
120–160 g/m²	40–50 μm	8–10 m²/l
2 x 120–160 g/m²	80–100 μm	4–5 m²/l

Practical coverage depends on the application method, painting conditions and the shape and roughness of the surface to be coated.

### **Drying times**

120–160 g/m²	+23°C	+50°C
Recoatable, after	2–4 h	5–20 min

The paint can be dried in convectional air drying oven with temperature +40-60°C.

Drying and recoating times are related to the wet film thickness, color shade, temperature, the relative humidity of the air and ventilation.

## **Ultra Pro Plus 30**

#### **APPLICATION INSTRUCTIONS**

Surface preparation Clean surfaces from dirt, dust and loose material. Assure that surface is free from mold

and blue stain.

**Recommended primers** Ultra Pro Plus 30.

Ultra Pro Plus 30 is recommended to be used both as a primer and a top coat.

Recommended topcoats Ultra Pro Plus 30, Ultra Classic.

Can be coated with Ultra Classic paint in building site, if needed.

**Application conditions** The surface to be treated has to be clean and dry. The moisture content of wood has to

be below 20%. During application and drying temperature of the air, substrate and product must be over +10°C and relative humidity of the air below 70%. Good ventilation

is required to ensure optimal result. Product can be dried with or without oven.

**Application** Stir the product carefully before use. Avoid making foam.

For airless spraying the product is thinned approximately 0–5%. Recommended nozzle tip is 0.013"–0.015" and pressure 140–180 bar. Spray angle shall be chosen according to

the shape of the object.

For air-assisted airless spraying, the product is thinned approximately 0–5%. Recommended nozzle tip is 0.013"–0.015" and pressure 40–140 bar. Atomising air pressure should be about 1–3 bar. Spray angle shall be chosen according to the shape of

the object.

For conventional spraying, the product is thinned approximately 0-5%. Recommended

nozzle tip is 1.6-2.0 mm and pressure 2-3 bar.

Wood contains resin and other colouring extractives especially in knots. Temperature

and humidity fluctuations may cause paint coat discolouration in these areas.

**Thinners** Paint is recommended to be used without thinning. If needed thin with water max. 5%.

Cleaning of equipment Water or Tikkurila Tool Cleaner.

**VOC** According to VOC Directive 2004/42/EU the product subcategory A/d VOC limit (1.1.2010)

is maximum 130 g/l. VOC content of "Ultra Pro Plus 30" is 35±10 g/l.
