SECTION 5: Firefighting measures**5.1 Extinguishing media**

Wash hands before breaks and immediately after handling the product.

7.2 Conditions for safe storage, including any incompatibilities : Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Keep container tightly closed. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Recommended storage temperature is +5°C ...+25°C.
