SECTION 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media : Use an extinguishing agent suitable for the surrounding fire. Recommended: Alcohol resistant foam, CO₂, powders or water spray/mist.

: Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Do not allow to freeze. Store in accordance with local regulations.
